



COURSE TITLE	Advanced WESM Training on Governance and Compliance
COURSE REQUIREMENT	This course serves as a follow-up training on the Wholesale Electricity Spot Market (WESM) for all WESM Members and other qualified participants; To enroll, the Basic WESM training shall have been completed. Interested parties must comply with the training enrollment process in order to be accommodated to the course.
COURSE OBJECTIVE	This course aims to familiarize the participants with the WESM governance committees and their functions, market monitoring indices and market monitoring in general, and the enforcement and compliance framework in the WESM.
DURATION	1 day (approx. 5 hours and 45 minutes lecture hours + 0.5 hour for pre-lecture introductions)

I. COURSE DESCRIPTION

This course will aid the market participants in understanding the role of the governance committees in the WESM and the processes attendant to it to ensure the realization of WESM objectives. This course will also include presentations and discussions on the market monitoring indices that are being used to assess the WESM. Finally, this course will cover the legal and regulatory framework in the enforcement and compliance in the WESM.
